2021 - Happy New Year for the Chamber Staff!

We at the Chamber like so many others are happy to be putting 2020 behind us. Somehow, the words "global pandemic" did not appear in our strategic plan last year and we doubt anyone was prepared for how last year went.

Despite the limitations on many live events, thanks to the generosity and assistance from our members we were able to hold not only the 4th of July Fireworks, and a Holiday Parade. We were able to hold many educational events virtually including a fall leadership series. We assisted with a grant program to distribute small business assistance funds to the tune of \$3.5 million for our region, and \$1 million for Alpena County. Beyond that we were able to help assist our members with other relief funding programs by getting them the most current information and connecting our members with those that could bring even more assistance.

Despite our current restrictions and an unknown timeline for returning to normal, there is plenty of reason for optimism in 2021. One piece of good news is a new round of small business assistance is in the process of being rolled out. Much like last year, Chamber staff will assist the State in getting those funds out quickly and ensure that relief dollars reach our local businesses (we will be sending out further details in enotes and keep an eye on alpenachamber.com for additional information). In addition, most people are receiving a federal stimulus check as well, and as always, the Chamber is asking those that have the ability, to spend these funds locally! The health department has been updating us on the status of the vaccine rollout and indicated that first responders and many health care workers have begun the vaccination process, with educators and senior care facilities coming soon.

Here at the Chamber, we are looking forward to holding our Annual Dinner and Grub Crawl although perhaps later in the year than usual. We anticipate a very busy summer/fall as soon as group gatherings are feasible, not only with the Chamber but many other valued community groups going all in to make these events as special as possible.

Chamber Staff is looking forward to everything we can accomplish in 2021. As usual we appreciate your continued membership to help us to continue to benefit and empower our members and continue to build up this community. We will continue to work for your benefit to add value to your membership through economic development, educational opportunities, exposure, advocacy and savings.

Strategic Plan Update

Advocacy

Staff continues to work with the Northern Michigan Chamber Alliance. In addition, the Governor has recently opened up an office for the northern lower portion of the state. The assigned liaison is Haley Hildebrand. This is a new office located in Traverse City. Hopefully this will enable additional communication between our area of the State and the executive office. President & CEO Adam Poll was also invited to participate in the Lafarge Community Advisory Council which took place recently. The group discussed Lafarge's continued environmental efforts as well as diversity in the work place.

Education

Adam recently attended (virtually) his first Career and Technical Education meeting. This program partners various groups with APS students and they have asked that the Chamber help them connect our membership with APS depending on the topic they are covering. Similarly, he is working with Jamie Kurowski in the Career Navigators group helping her get contacts for various subjects as well.

In addition to this, the Chamber held a digital leadership series. The series consisted of three morning sessions. Because of the format, numbers were restricted but the event was well attended.

We also continue to keep the website updated as well with the most up to date information regarding COVID protocols and educational materials.

Exposure

Recently staff was able to hold a variation of the annual holiday parade with the help of the Alpena County Fairgrounds. It was delayed to adjust for a drive thru format, but working with County Commissioners and Fairground staff, we were able to organize the event in such a way that parade traffic did not cause as issues on the City streets. We had floats from WATZ, Huron Shores Fellowship Church, Player's Pub & Grub, Eagle Supply Co. Clark Construction and Northland Area Federal Credit Union housed Santa Claus on their float. We received nothing but positive feedback.

Economic Development

Our staff continues to work with developers on various economic development projects. We were able to write letters of support for several special use requests on US-23 South, and there is continued interest on the M-32 corridor. Staff continues to act as a connection point to make sure any potential development moves as smoothly as possible. We were also recently informed that we will be administering another round of grants through the MEDC.

Military Support

Due to COVID our December Community Council meeting did not take place. Col. Rossi, Sgt. Hatala, the Mayor and Adam will be meeting soon to put a plan together for the next meeting. We recently donated military support funding to cater a meal for base personnel on New Year's Eve. Their current mission has them housing several hundred troops prior to deployment and this would give the support staff a nice evening celebration.
